The submission of any photographic film, prints, video, cd/dvd, digital images or negatives constitutes an agreement that in the event of loss or damage by Wolverine Media, liability extends only to replacement of materials with an equivalent amount of video, film or processing, or full refund of all deposits paid. Except for such replacement, the handling of film, prints, video, cd/dvd, digital images or negatives is without warranty or liability.

Wolverine Media is not bound to the terms of this agreement until all required fees are paid and accepted.

The videographer/videographer/photographer's time begins as indicated on the front of this agreement, or on the Planning Worksheet. It is understood and agreed that the prices shown, are those currently in effect. Prices given over 90 days in advance are subject to change, unless a deposit, or payment in full is made.

The contracting parties, and those acting on the behalf of others, acknowledges the videographer/photographer's right to use film, prints, video, cd/dvd, digital images or negatives and/or reproductions for display, publication or other purposes. Finished product from Wolverine Media, i.e. - film, prints, video, cd/dvd, digital images or negatives and previews, remain the exclusive property of Wolverine Media.

In the event of a postponement or cancellation of the event, or default on payment of all fees, as agreed upon, the deposits paid are non-refundable.

A consultation with the Bride and Groom is required to plan your wedding videography desires. Wolverine Media will book weddings on first come, first served basis only, with a deposit required to reserve your wedding date and time. No wedding is booked until the deposit is paid. Full payment of the balance, is due thirty (30) days prior to the wedding date.

Weddings booked four (4) weeks or less before the ceremony date, must be paid for in full, to reserve the wedding date and time. At the time any wedding is scheduled, a "Videography Contract" must be signed.

No travel expenses will be charged within 50 miles of the Lansing area. Outside of the Lansing area, a mileage fee will be charged to and from the ceremony and/or reception unless otherwise noted on the contract. (Travel time is based solely upon mileage at a rate of .90 cents per mile).

A meal will be provided to representative(s) of Wolverine Media at no cost, during Reception.
